REQUIREMENTS OF THE INVESTMENT PROMOTION ACT:

4. If the Enterprise named in this Certificate ceases to carry on business in any activity set out on the face of this Certificate, the Investment Promotion Authority must be notified accordingly.
5. If there are changes in those details supplied to the Authority by the Enterprise in its Application for Certification the Enterprise is required to advise the Authority for those changes within one month of the date of the change.
6. Failure to comply with the Investment Promotion Act or any term of this Certificate is an offence.
